1. About MSAC International

MSAC International is an independent international sports organization dedicated to the development of Military and Sports All-Round Competitions worldwide.

2. Event Registration

- All information provided must be accurate, complete and truthful.
- Submission of a registration form does not automatically guarantee participation.
- Participation becomes valid only after confirmation by the Organizing Committee.
- MSAC International reserves the right to refuse or cancel participation where necessary for safety, eligibility or organizational reasons.

3. Medical Fitness and Insurance

Every participant confirms that:

- They are medically fit to participate in combat sports competitions;
- They have no medical condition preventing safe participation;
- They have valid sports accident insurance covering the entire event.

MSAC International does not provide personal accident or medical insurance unless explicitly stated by the event organizer.

By participating in any official MSAC activity, you acknowledge these risks and agree that you participate voluntarily and at your own responsibility. MSAC International, its organizers, officials, volunteers, partners and venue providers shall not be liable for injury, illness, loss, theft or property damage except where liability cannot be excluded under applicable law or results from gross negligence or willful misconduct.

- Instructions of the Organizing Committee.

Failure to comply may result in warnings, penalties, disqualification or removal from the event.
